1. Secretary Reports from Mar. 14th meeting (Kenzie)

a. Meeting minutes were approved

2. Treasurer Report (Tyler)

- a. \$450 for spring camp supplies and shipping
- b. We are up \$25,168.16 from this time last year
- c. Total value of \$135,164.37
- d. Treasurer report was approved

3. Committee Updates

- a. Camp Planning (Julie)
 - i. Summer Camp
 - 1. Everyone would have to be vaccinated
 - 2. Easter Seals is okay with us having less people than on our contract
 - 3. Everyone has to bring their own volunteer
 - a. We won't recruit for new volunteers
 - b. If you don't bring a volunteer, you might not be able to come
 - 4. Should shoot for around 25 campers
 - 5. Possibly have a visiting day for people who can't find a volunteer for the week
 - a. Do outdoor activities
 - 6. Space out the dorms more since there are less people
 - 7. Possibly require a negative COVID test the Monday before camp
 - a. Give people the option to do a rapid COVID test when they get there if they can't get a test before
 - b. Suggest staying home after being tested so that people don't drive all that way and then be sent home because of a positive rapid COVID test
 - 8. Send out a survey to see what our camp community thinks about requiring vaccinations and COVID tests and in person versus virtual camp
 - 9. Easter Seals precautions
 - a. Rapid COVID test
 - b. Temperature checks everyday at lunch
 - c. We don't have to follow their rules because we are renting from them
 - 10. Hybrid camp with some virtual activities
 - 11. Is it worth having camp in person?
 - a. Send out a survey and go from there
 - i. Add alternative options to see what people want to do

- 1. Hotel camp for one night?
- 2. Cookout at a park?
- 3. Weekend camp instead of week long?
- ii. Emergency board meeting after the survey to make a decision by Memorial Day
- iii. Send out survey by May 17
 - 1. Close it on May 24

- b. Fundraising (Tyler)
 - i. Tyler has the raffle tickets printed and ready to go
 - ii. Fundraising in a grocery store
 - 1. Brat sale -- and sell raffle tickets
 - iii. Possible grant/sponsorship with Biogen
 - 1. Kenzie and Haley will be meeting with the Biogen rep next week to discuss it more
 - 2. After we have more information, possibly going to Evrysdi rep to see if they are interested as well
 - iv. Dip fundraiser
 - v. Restaurant fundraiser
 - vi. One Mission fundraiser this summer
 - vii. Reschedule fundraising meeting before the end of the month
- c. Website (Lauren)
 - i. Had to reschedule meeting
 - ii. Website will be the same but with a different template
- d. Bylaws (Joe)
 - i. Haley has a draft with suggestions and revisions and will be sending it out soon
 - 1. We need every board member's feedback!!
 - ii. Once finished, we will present it to the general membership at camp and see if they approve it
- e. Succession Planning (Haley, Erica, Nicole)
 - i. Erica made a survey about how the individual board members are doing, then have individual meetings with Haley or Joe
 - 1. Recognition and seeing if each member is contributing to the board
 - 2. Possibly present it to the general membership so that they have feedback before voting people onto the board

 - iii. All of these are things from the strategic planning with Kim
