1. Secretary Report from 5/12/22 meeting (Kenzie)

- a. Meeting minutes were approved
 - i. Tyler motioned to accept the minutes, Lauren seconded

2. Treasurer Report (Tyler)

- a. Tyler will put it in Slack for everyone to review by Friday
 - i. Everyone will need to review it and vote on Slack by Sunday
- b. Sent a check to Julie for shirts for camp

3. Presidential Remarks (Nicole)

4. Committee Updates

- a. Camp (Julie)
 - i. 3 new campers between the ages 18-20
 - 1. We don't have volunteers in order to accept them
 - a. Need 2 more female volunteers
 - b. Need 3 more male volunteers
 - ii. \$1400 in gift cards, mostly to Target
 - iii. Ask that everyone brings a 12-pack of soda or water
 - iv. If everyone can request free COVID tests, that would save us a lot of money
 - v. Spent \$2400 on camp so far, \$1000 of that on shirts
 - vi. Sent out calendar and menu for camp
 - vii. Should we have a talent show/lip sync/karaoke?
 - 1. Not a lot of interest in this activity in the past
 - 2. Night swim/game night at the pool instead!
 - viii. Boat rides are \$11/person but we would have to transport individually, ziplining is \$15/person

- 1. Julie will ask Easter Seals about transportation
- 2. Ziplining would be more feasible so we will do ziplining this year and look into boat rides for next year
- ix. Joe will reach out to confirm everything with the Corvette Club
 - 1. Discuss vaccination and/or COVID test prior, encourage but not required
- x. Need more nurses if possible, especially to administer COVID tests
 - 1. When campers arrive at camp, they must first come to the table to get their COVID tests before unloading
 - a. Make sure to relay this information ahead of time before they arrive
- b. Fundraising (Tyler)
 - i. \$200-300? for apparel fundraiser
 - 1. Change it so it runs through camp so we can encourage buying throughout the week
 - a. Donnie will reach out about this
 - ii. We need to get going on the sweepstakes
 - 1. Competition for that as well?
 - 2. We aren't breaking even yet so we really need to push selling before camp
 - a. We need \$1,000 to break even, we are at about \$200 right now
 - iii. WALHtoberfest \rightarrow venue will work, tentative date of September 17th, 2022
 - 1. Jenny will work on silent auction
 - Competition at camp for whoever sells the most tickets
 a. Free ticket to the event as a prize?
 - 3. Will create a committee for this event on Slack
 - iv. Restaurant fundraiser in Madison
 - 1. Tyler will follow up and see how much we made
- c. Bylaws (Joe)
 - i. Vote on by bylaws
 - 1. Donnie motioned to approve bylaws to present at general membership meeting, Jim seconded
- d. Succession Planning (Nicole)
 - i. Finished! Please fill them out by July 17th and I will compile results for the board meeting at camp. I won't share what you said about others
